EPA CERTIFIED APPLIANCES

EPA (Environmental Protection Agency) Emission Standards

To be Phase i EPA certified, stack emissions are limited to the following:

- 8.5 grams of particulates per hour for non-catalytic models.
- 5.5 grams per hour for catalytic models.

To be Phase ii EPA certified, stack emissions are limited to the following:

- 7.5 grams of particulates per hour for non-catalytic models.
- 4.1 grams per hour for catalytic models.

To be Phase iii EPA 2015 certified, stack emissions are limited to the following:

- 4.5 grams of particulates per hour for non-catalytic models.
- 4.5 grams per hour for catalytic models.

NOTE: Washington state has more stringent regulations for maximum grams per hour emissions allowed (included in table below). Check with your local authority having jurisdiction for requirements in your area.
